Fall Semester is Here!

Below are some important start of the semester reminders. As you return to classes for the fall 2016 semester, please check your class lists on eServices under class management. Please be aware of the time and where your classes are meeting, as that can change after the semester begins. Students are not allowed to sit in classes they are not registered for.

Drop/Add Deadline: The deadline for dropping and adding courses is **August 26, 2016, at 4 p.m.** No entry will be made in a student's record if a course is dropped before this date.

Class Permissions: After the **August 26th** deadline, a student can no longer *add* courses via eServices. A department issued 'registration permit' will be required to add any courses and must be processed in the Registrar's Office. The permit must be signed by the student and the instructor teaching the course.

Withdrawal Deadline: Students may continue to drop classes after **August 26th**, but will receive a 'W' on their academic record. Withdrawal deadlines vary for half term and full term sessions. For most full-term sessions the deadline is **November 21, 2016**; however we advise checking the course schedule in eServices for specific deadlines for each course.

Waitlists: Waitlists for the 2016 fall semester courses will end on **August 26, 2016**. Waitlists are lists of students waiting to get registered for a course that is full. If a student is on a waitlist for a course, they will receive a notification sent to their mnstate.edu email account. The student will have 24 hours after being notified to go to eServices and register for the course.

Faculty Overrides and Edit Codes...

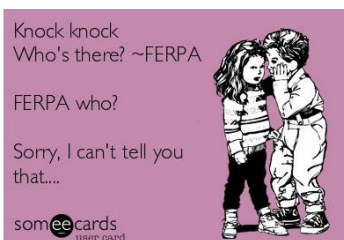
We know change is difficult, but we like to keep you on your toes! This summer, two changes were implemented by MnSCU in regards to faculty overrides and edit codes. Here is what you need to know:

Faculty Overrides: The instructor for a course will still be able to enter an override like they always have; however if anyone other than the instructor wants to enter an override for a course they need special security permission to do so and will need to enter the override on a different screen. To request security, please contact Shawn Soderberg in the Registrar's Office. Detailed instructions can also be found on the Registrar's Office website under Faculty Resources.

New Edit Code 68: MnSCU has retired a number of edit codes (including edit 58) and created/combined them into one edit code 68. This edit will be used to handle all test score and prerequisite restrictions for a course. More information will be sent out in September.



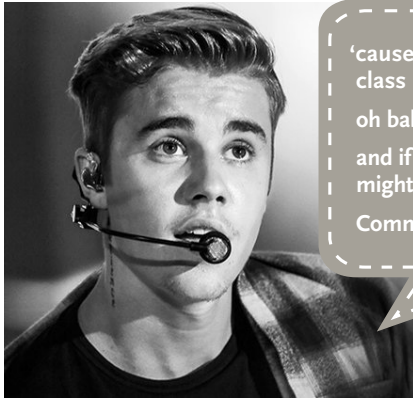

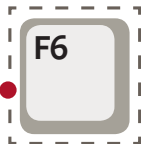
