Minor Curriculum Revisions

The following minor curriculum revisions were approved:

Change in prerequisite for Psy 301, People, Work and Organizations. The course prerequisite should read: Psy 119 (or equivalent social psychology), or 12 hours of psychology, or consent of instructor.

Reduce from 4 to 3 the number of graduate credits offered in the upper division courses in developmental psychology (Psy 401g, Child Psychology; Psy 402g, Adolescent Psychology and Psy 403g Adulthood and Aging). The number of undergraduate credits for these courses will remain 4 each.

Change in course title for Psy 119 from Interpersonal Psychology to Social Behavior.

Renumber the following Social Work courses:

SW 200 to 250

SW 302 to 355

SW 431 to 451

SW 401 to 301

SW 402 to 302

SW 403 to 303

SW 404 to 304

SW 461 to 432 This shall be an "honors" course for those students who hold a GPA of 3.00 or above. Sociology 350 - Research Methods, plus Social Work 259 shall be prerequisites.

SW 462 to 421

Retitle the following Social Work courses:

SW 259 to Social Work Practice I

SW 359 to Social Work Practice II-Interviewing

SW 459 to Social Work Practice III

SW 304 to Social Work in a Rural Environment

SW 302 to Children's Services

Delete the "G" designation for SW 303, Social Work and Health Related Fields and SW 304, Social Work in a Rural Environment.

Add the "G" designation for SW 406, Advocacy and SW 409, Social Work with the Elderly.

Art 268

J. Kaplan moved, J. Holland seconded, to approve Art 268, Glass Blowing, 3 cr. Motion carried unanimously.

Recreation and Leisure Studies Major

L. Frederickson stated that this major would be offered in cooperation with North Dakota State University.

R. Szeitz suggested that instead of requiring Art 100 under the Arts and Crafts area of the major that the student be allowed to take any one of the following four art courses: Art 100, Elements of Art; Art 150, Ceramics; Art 189, Basic Techniques of Weaving or Art 175, Jewelry Making.

L. Grugel moved, R. Szeitz seconded, that the department be asked to prepare an addendum to the proposal that would address itself to some of the issues raised in the discussion regarding the preparation to serve the elderly and the handicapped. Motion carried unanimously.

Social Work - Degree Designation

F. Zahroon moved, W. Wesley seconded, to approve the request that the Department of Social Work change its degree designation to Bachelor of Social Work - BSW. Motion carried unanimously.
