Once a student submits the form, the release will stay on the student’s record and no longer expire after one year. A student has the option to rescind the release at any time. ## Transfer Pathways

**Transfer Pathways** is a new program to ensure that Minnesota State Colleges students who complete associate degree programs (AA, AS, and AFA) can transfer seamlessly to Minnesota State Universities. It is a curriculum plan for a student who plans to pursue a bachelor’s degree after completing an associate degree. Transfer pathways are being developed for 30 majors and programs in Minnesota State institutions.

Each transfer pathway will describe all of the lower-division major content and competency requirements needed to prepare students to enroll in the major at the university. The pathway will identify any necessary pre-requisite courses, as well as the general education courses needed for the Minnesota Transfer Curriculum (MnTC). The lower-division curriculum will also include any experiential learning activities required for the university major or program (e.g., service learning, internships, undergraduate research). Students who have completed a transfer pathway associate degree will transfer into the university at a junior level. They will be eligible for admission to the major in the same way and on the same basis as direct-entry university students.

The four programs that have been approved to be effective fall 2017 are biology, psychology, business, and theatre arts. The Registrar’s Office has been working with these departments for plans on how credits will transfer and how curriculum will be set.
