## Good News!

Due to changes in PELSB Unit Rule, the PERCA reporting cycle and process has changed.

This means we do NOT have to submit PERCA reports until Fall 2023!

## **PELSB Updates**

- New Unit Rule has now been fully approved.
- The PERCA cycle has changed from a two year to a three year cycle with adjustments made so PERCAs are not due the same year as a unit's site visit.
- The Standards of Effective Practice (SEPs) are still under rule review with continued emphasis on:

- Cultural Competency
- Building Relationships
- Social-Emotional Learning
- o Trauma
- Technology
- Professional Dispositions
- Once the SEPs are adopted courses and syllabi will need to be revised!
- The next large group of standards set to be reviewed and revised include Early Childhood, Elementary, Early Childhood Special Education, Arts, and ESL. As soon as the SEPs are finalized, this group of standards will likely be opened.
- Initial licensure applications are now online. Diane Copple has done a fantastic job of distributing guidance documents for our candidates!

## **Minnesota Teacher Licensure Exams (MTLE) Updates**

PELSB's new contract with Pearson for administering the MTLE's offers several new advantages for test takers.

#### MTLE updates include:

- ✓ All MTLE Pedagogy and Elementary Education Content Tests will be available online this summer. This means candidates can take the exams at home if they choose.
- √ Free MTLE testing will also be available after a taker's failed 2<sup>nd</sup>
  attempt.
- Enhanced score reports will be available in the fall.
- Double testing time will be available for non-native English speakers beginning in the fall.
- ✓ Several tests will be made available in Spanish, Hmong, and Somali.
- ✓ Test vouchers for \$25.00 will still be available. The number of tests vouchers available will increase this fall.
- ✓ In late August or September, there will be a slight increase in sub-test fees.

### A Sneak Peek at Fall

- Changes to SARTE requirements will take effect this fall.
   The change includes no longer requiring SPED 225 for SARTE admission. This change accommodates the revision to secondary/K-12 programs to require SPED 413 instead of SPED 225.
- Students will purchase Tk20 near the beginning of their ED 205 semester. This will ensure a fully functioning data collection system is in place for field experiences.
- Tk20 will be utilized for the curriculum worksheet process. Information will be provided during the fall Teacher Education meeting.
