Minutes of the Academic Policy Advisory Council Tuesday, March 13, 4:00 p.m., Owens A

Members Present: W. Jones, Chairperson; L. Grugel, L. Bergquist, D. Olson, Molly Moore, D. Huebner, C. Kale, J. Strong, R. Szeitz, W. Wesley, F. Zahroon, Margaret Moore, R. Jones, N. Parlin, W. Treumann

Revision in Requirements for B.S. in Math

J. Strong moved, Molly Moore seconded, to approve the proposal to require, as a related field requirement, that B.S. (teaching) majors in mathematics complete Computer Science 150 (Introduction to Digital Computers) in addition to the present requirement of 57 credits in mathematics. Motion carried.

Internship Subcommittee Report

R. Szeitz moved, L. Grugel seconded, to approve that (1) there be some way of differentiating between the number of credits granted for an internship and (2) the grading of internships be on an S/N (satisfactory - no credit) basis. J. Strong moved, F. Zahroon seconded, to divide the question. Motion to divide the question carried. Motion to approve the concept of variable credit for an internship carried.

- F. Zahroon moved, J. Strong seconded, to table the motion to grade internships on an S/N basis. Motion to table was defeated. Motion to approve the grading of internships on an S/N basis was defeated.
- R. Szeitz moved that internship credit be awarded on a sliding basis. Motion died for lack of second.

Discussion of procedures for administering variable credit for internships was postponed.

Graduate Subcommittee Report

The Graduate Subcommittee Report was discussed.

W. Jones announced that unless there were substantial reservations from APAC, departments could continue with studying feasibility of new master's programs for eventual consideration. Two such programs are scheduled for further exploration: A Master's in Social Work, and a Master of Liberal Studies.
