Minutes of the Academic Policy Advisory Council October 15, 1979, 4:00 p.m., Owens A

Report from the General Studies Subcommittee

W. Wesley moved, R. Szeitz seconded, to approve recommendation 5. N. Whyatt moved, Molly Moore seconded, to amend the motion to include the statement that in selecting the committee it will normally be desirable to maintain three members from one year to the next. Motion to amend carried. Amended motion carried with one opposed.

An APAC Sub-Committee on Liberal Arts will be established to evaluate every course submitted for Liberal Arts approval. After initial implementation a three year cycle will be established for re-evaluation of approval. The committee should have representative membership including faculty, students and administrators. Its membership should be ten; one from each of the five academic divisions, two at large from the liberal arts disciplines, two students and one administrator. It will normally be desirable to maintain three members from one year to the next.

N. Whyatt moved, W. Wesley seconded, to approve recommendation 6. Motion to approve recommendation 6 carried with one opposed.

Topical courses or seminars must be approved individually but the approval can come the quarter before the first offering.

F. Zahroon moved, N. Whyatt seconded, to approve recommendation 7. R. Szeitz moved, Margaret Moore seconded, to delete recommendation 7 and substitute 10b. Substitute motion carried unanimously.

The committee should develop and implement, with admissions personnel, an efficient plan for evaluating transfer-student programs.

Molly Moore moved, Margaret Moore seconded, to approve recommendation 8. Motion carried.

All courses will carry a liberal arts designation on both the class schedule and on the student's transcript. The division should also be designated on the transcript and on the schedule

W. Wesley moved, N. Whyatt seconded, to approve recommendation 9a. Motion defeated 4-5.
