Report from General Studies Subcommittee

W. Wesley moved, N. Whyatt seconded, to remove recommendation 3 from the table.
Motion carried.

Margaret Moore moved, D. Gasal seconded, to amend the second sentence in the
paragraph regarding recommendation three to read: These courses will be team
taught by two or more faculty members representing at least two different disciplines
one of whom must be a faculty member from a liberal arts division but not both from
the same division. Motion to amend carried unanimously.

N. Whyatt moved, R. Szeitz seconded, to add the following statement to recommendation
three: A formal review to evaluate the interdivisional requirement will be made
in the Fall of 1986 and the requirement would be continued or dropped based on
formal review. Motion to amend carried. Recommendation 3 carried as amended.

R. Szeitz moved, W. Wesley seconded, to approve recommendations 1 through 9 as
amended. N. Whyatt moved, Margaret Moore seconded, to table and to circulate
the amended recommendations to the faculty. Motion to table carried.
