New Process for Registration Permits

In an effort to move our forms online and to better serve our students, we are discontinuing the use of the paper registration permits. Registration permits are used to add a course after the free add/drop period the first five days of the semester.

The new process is as follows:

- ▶ A student who wants to register for a course after the semester's free add/drop period (first five days of the semester) will need to contact the instructor, but will do so by email. The email will need to include the student's name, student id, semester, course subject and number, course id, and # of credits (if variable credit course).
- ▶ If the instructor grants the approval, they will reply to the student's email and copy in the Registrar's Office (registrar@mnstate.edu).
- ▶ The Registrar's Office will process the registration and email both the student and instructor to confirm.



The Graduation Planner

We are excited to announce that MSUM has been chosen to be a pilot phase 2 school for the new graduation planner. We wanted to be in the first phase but you can't win them all. The team at MSUM that will be working on the planning, building, training and implementation of the planner includes Heather Soleim, Registrar; Sarah Jegela, Associate Registrar; Erika Beseler-Thompson, Director of the Academic Support Center; and Laura Kiemele, Academic Advisor/Program Coordinator.

The Graduation Planner

- ▶ Is integrated with the degree audit (DARS) and will be accessed through eServices
- ▶ Will allow our institution to create interactive roadmaps that more clearly define a path to graduation
- ▶ Encourages students to use these roadmaps to build their own personal plans, helping them stay on track to meet their educational goals
- ▶ Allows for the creation of term by term plans which will provide institutions with valuable aggregate data needed for demand analysis and classroom scheduling

Our office will be reaching out to all academic departments on campus to get information on their 4-year plans for their degrees. We will also be sending out a list of all active courses offered in each department to get information on the offering schedules. All of this information will be vital for building these interactive roadmaps. We are very excited to take on this project to increase student success and timely graduation, and because registrars love technology!
