Minor Curriculum Revision

The following minor curriculum revisions were approved:

Change in title for Special Education 401(g) to Ecological Assessment of Children.

Change number of credits for MDS 170, Studies in Popular Culture from 4 to 1-4.

Change in number of credits for Political Science 321, The American Presidency from 3 to 4.

Engineering 201, 205, 206

F. Zahroon moved, R. Szeitz seconded, to approve Engineering 201, Surveying: A Working Lab (3); Engineering 205, Public Land Surveying (5); Engineering 206, Land Law (3). Motion carried.

MDS 120
