#### Minor Curriculum Revisions

The following minor curriculum revisions have been approved:

Change in title and # from Sp. Ed. 271, Creative Arts for the Young Child to Sp. Ed. 372, Art, Music & Literature for the Young Child, 3 cr.

Change from Sp. Ed. 467(g), Practicum: Diagnosis and Treatment of Learning Disorders I, 6 cr. to Sp. Ed. 467, Practicum I: (Specific area to be appended), 3-9 cr.

Change from Sp. Ed. 468(g), Practicum: Diagnosis and Treatment of Learning Disorders II, 6 cr. to Sp. Ed. 468, Practicum II: (Specific area to be appended), 3-9 cr.

Change from Sp. Ed. 567, Advanced Practicum I: Emotionally Disturbed, 9 cr. to Sp. Ed. 567, Practicum I: (Specific area to be appended), 3-9 cr.

Change from Sp. Ed. 568, Advanced Practicum II: Emotionally Disturbed, 9 cr. to Sp. Ed. 568, Practicum II: (Specific area to be appended), 3-9 cr.

Change from Sp. Ed. 569, Advanced Practicum, 3-9 cr. to Sp. Ed. 569 Advanced Practicum: (Specific area to be appended), 3-9 cr.

Change from Sp.Ed. 590, Seminar: Current Trends in Special Education, 3 cr., to Sp.Ed. 590, Seminar: Current Trends in Special Educ. 1-3 cr.

Cross-list Educ. 592. Admin. and Supervision of Remedial Reading, 3 cr. with Sp.Ed. 592.

Add Sp.Ed. 595, Special Problems, 1-6 cr. to the Sp.Ed. listings.

Add Sp.Ed. 597, Individual Study, 1-3 cr. to the Sp.Ed. listings.

Add Sp.Ed. 599, Thesis in Special Education, 1-6 cr. to the Sp.Ed. listings.

Change in course designation within the department - Change Humanities 221, 222 and 223 to the designation American Studies 221, 222, 223, 20th Century I, 20th Century II and 20th Century III.

Change in required courses in Medical Technology Program: Biology 343 Microtechnique to be replaced as a required course by Chemistry 222, Instrumental Analysis.

Associate of Science, Law Enforcement

D. Corrick moved, A. Mudgett seconded, to approve the proposal for an Associate of Science, Law Enforcement, with the two corrections in wording suggested by APAC members: (a) that the reference to qualifications of general studies faculty be deleted and (b) under the General Studies heading list "one course in cultural diversity," instead of elective. Motion carried.

# Subcommittee on International/Global Education

- L. Grugel moved, M. Moore seconded, to remove the motion to establish an APAC Subcommittee on International/Global Education from the table. Motion to remove from table carried.
- L. Grugel moved, D. Gasal seconded, whereas the lack of attention paid by American Colleges and Universities to international education and global studies has been well documented (most recently by the Minneapolis Tribune, January 20, 1981); and whereas we are somewhat unfamiliar with the degree to which the curriculum at Moorhead State does foster global/international education; and whereas the APAC finds itself all too often in a position of reacting to proposals rather than initiating them, I move that an APAC subcommittee on International/Global Education be created and given the following charge:
  - To assess the degree to which international studies and an understanding of global concerns are fostered within the curriculum at Moorhead State University;
  - 2. To make, if the committee concludes it desirable to do so, recommendations concerning international studies/global education to the APAC for consideration and transmission to the Administrative Academic Council.
  - 3. That this report be presented to the APAC during the current academic year at which time the subcommittee will be terminated having accomplished the charge assigned it.

Motion carried.

### Accting 330, 331, 332

S. Roy moved, C. Brainard seconded, to approve Accounting 330, 331, 332 Intermediate I, II, III (4 cr. ea.). Motion carried.

#### AAC Recommendation on New Center Admissions

The AAC recommendation on limiting enrollment in the New Center was discussed. No action was taken at this time.

## Minor in English, Writing

M. Holoien moved, B. Midgarden seconded, to approve the Minor in English, Writing. Motion carried.
