Minor Curriculum Revisions

The following minor curriculum revisions were approved:

Change Chem. 105, Intro. to Nutrition to Health 105  
Change credits for German 331 from 4 to 3 and add Roman numeral I to the course title.

Health 215, 330(g), 410(g), 415(g)

M. Moore moved, D. Corrick seconded, to remove consideration of the Health course proposals from the table. Motion carried.

M. Moore moved, A. Mudgett seconded, to approve Health 215, Health Agencies and Services (4). Motion carried.

The HPER department submitted a revised description for Hlth 400 including a change in number to 330. M. Moore moved, D. Corrick seconded, to approve Health 330, Introduction to Diseases (4). Motion carried.

M. Moore moved, A. Mudgett seconded, to approve Health 410(g), Consumer Health Education (3). Motion carried with one opposed.

D. Corrick moved, M. Moore seconded, to approve Health 415(g), Design and Evaluation of Community Health Education Programs (3). Motion carried.

M. Moore moved, A. Mudgett seconded, to vote on the four minor revisions at one time. Motion carried. M. Moore moved, C. Brainard seconded, to approve the four minor revisions as follows:

Change course description for Hlth 326, Epidemiology to: A study of the distribution of disease with an emphasis upon interrelationships among culture, social organizations, environment, and population changes.

Add prerequisite to Hlth 340, Health Education Methodology. Prereq: Hlth 330 or consent of the instructor.

Change in title and description for Hlth 465(g) to Organization and Administration of School Health Programs. Change description to: A study of the philosophy of school health and the policies and procedures used in coordinating such programs.

Drop Health 390, Health in the Elementary Schools.

Motion carried.
