MINUTES OF THE ACADEMIC POLICY ADVISORY COUNCIL Tuesday, April 28, 1981, 4:00 p.m., Owens A

Liberal Arts Committee Report

M. Holoien moved, D. Corrick seconded, to approve the Liberal Arts Committee's recommendation that if the department requests liberal arts credit for a new course, the course proposal should be routed to the Liberal Arts Committee first and then to APAC. Motion carried.

Revisions in Business Administration Curriculum S. Roy moved, C. Brainard seconded, to approve the proposed change in Social Science requirements for Business Admin., Marketing and Management majors from Psych. 119, to Psych 119, Social Behavior or Soc. 205, Social Psychology. Motion carried.

L. Grugel moved, A. Mudgett seconded, to approve the proposed revised Business Administration Core requirements:

Acct. 229, 230, 231, Principles I, II, III (4 cr. ea. Acct. 301, 302, Business Law I and II (4 ea. Finc. 340, Corp. Finance I (4) Mktg 310, Principles of Marketing (4) Mktg 441, Business and Society (4) Mgmt 360, Principles of Management (4) Mgmt 460, Business Policy (4)

Motion carried.

B. Midgarden moved, M. Holoien seconded, to approve the proposal that the work experience courses, Mgmt 2452, 243, 244, Mktg 242, 243, 244 and Finc 242, 243, 244 will be counted only as free electives. Motion carried.

S. Roy moved, M. Holoien seconded, to approve the proposed option for Finance, Management and Marketing majors: Electives may include up to eight credits of upper level courses from other disciplines. The student must obtain written approval of the course from his or her academic advisor before taking the course as an elective. Motion carried.

S. Roy moved, A. Mudgett seconded, to approve the proposed revisions in the Business Administration major requirements as delineated in the proposal. The distribution of credits will be: General Studies 64, Business Admin. Core Requirements 40, Business Administration Requirements 36, Other related requirements 8, Free Electives 44. Motion carried. D. Corrick moved, D. Anderson seconded, to approve the proposed revisions in the Management major requirements as delineated in the proposal with the following credit distribution: Gen. Studies 68, Bus. Admin. reg. 44, Mgmt Req. 20, Management Electives 16, Free Electives 44. M. Holoien moved, A. Mudgett seconded, to amend the motion to approve the Management major with the credit distribution as follows: General Studies 64 Bus. Admin. core reg. 40 Mgmnt Requirements 20 Mgmnt Electives 16 Other related requirements 8 Free Electives 44

Motion to amend carried. Motion as amended carried with one opposed.

M. Moore moved, C. Brainard seconded, to approve the revised Marketing Major as delineated in the proposal with the following credit distribution: General Studies 64, Bus. Admin. Core requirements 40, Marketing requirements 20, Marketing electives 16, Other related requirements 8, Free electives 44. Motion carried.

M. Moore moved, R. Chang-Yit seconded, to approve the proposed revised Finance requirements as delineated in the proposal with the following credit distribution: General Studies 64, Business Admin. core requirements 40; Finance Requirements 20; Finance Electives 16, Related requirements 8, Free Electives 44. Motion carried.
