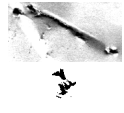

Minor Curriculum Revisions

The following minor curriculum revisions were approved:

Change Math 465 to Math 365 and change title to Vectors and Vector Fields, (prerequisite to Math 234).

Change in number of credits and course description for Health 340 to: Health 340, 4 credits. A student-involvement approach to procedures and materials used to facilitate learning experiences in a school or community setting.
