### IRB Policies and Procedures

### Computer Science Curriculum Revisions

J. Strong moved, D. Corrick seconded, to approve the new course proposals: Computer Science 245, Systems Analysis and Design (4) 380 Structure and Programming of Systems Software (4). Motion carried.

J. Strong moved, J. Charon seconded, to approve the proposed curriculum revisions in Computer Science. Motion carried.

### Report from Computer Science Department

M. Holoien reported on the accelerated courses in Coms 350, 351 and 352 that were offered during the summer of 1980. The department felt that they were quite successful. They plan to evaluate their admission procedures before offering the courses next summer and perhaps include the prerequisite of some programming. O. Sharma felt that the students who had gone through the summer program were well prepared for the masters program.
