APAC assumes that if that particular faculty person does not teach the course, the department can decide who else is qualified. When APAC considers a course submitted by a

committee, a list of the qualifications of the person who will teach the course should be provided. However, the committee should also designate the department responsible for the course (or departments), or in the case where there is no

designated department, the degree or other professional qualifications required should be listed. If a department is designated, then it is assumed that:

 control of course content will remain in the department. staffing will be determined by the department in

consultation with the committee or director of the program. 3. scheduling will be determined by the department in consultation with the committee or director of the program.

4. credits generated will be applied to the department. Change of Credit Value for Advanced Placement

and CLEP Exams J. Tesch moved, R. Bynum seconded, to approve the change of credit value for advanced placement and CLEP examinations. Four quarter credits will

be granted for successful completion of any single examination of either kind (Advanced Placement and Credit by CLEP Examinations). This policy would take effect Summer 1982. Motion carried. Lart 537
