Minor Curriculum Revisions

The following courses were dropped: MLA 511, The Idea of Progress; LART 519, Comparative Studies in the Genesis of Civilization; LART 525, Social and Intellectual Traditions of Black Americans; LART 537, History of Astronomy.

Japanese 297

D. Corrick moved, D. Anderson seconded, to approve Japanese 297, Independent Study in Japanese - Intermediate Level (1-4). Motion carried.

Mass Communications 351-357

S. Roy moved, W. Fischer seconded, to drop Mass Communications 355, Television News Writing and to approve the following sequence: Mass Communications 351, TV News Assignment Editor; 352 TV News Photography/Graphic Designer; 353 TV News Producer; 354 TV News Reporter, 355 TV News Videographer; 356 TV News Videotape Editor; 357 TV News Writer (1-4 cr. each). Motion carried.

Revisions in A.S. Degrees in Marketing/Business Administration

W. Fischer moved, D. Anderson seconded, to approve the revisions in the A.S. Degrees in Marketing and Business Administration. D. Corrick stated that he feels an associate degree should not require more than 96 credits and a student should be able to obtain an A.S. in two years. Motion carried 4-4-2.

Accounting 454(g)

D. Anderson moved, D. Corrick seconded, to approve Accounting 454(g), Advanced Managerial Accounting (4). Motion carried.

Philosophy 210

D. Corrick moved, R. Bynum seconded, to endorse the recommendation of the Liberal Arts Committee to approve the topics course Philosophy 210, Philosophy of Love, 2 credits, for Liberal Arts credit for Summer '82 only.

S. Roy moved, J. Tesch seconded, to table. Motion to table was defeated. Motion to approve carried.

It was agreed that procedures for APAC approval of Liberal Arts Subcommittee recommendations should be an agenda item at a meeting this spring.

J. Charon moved, J. Tesch seconded, that in the interim material accompanying the request for liberal arts credit for Music 215 should be forwarded to APAC. Motion carried.
