Minor Curriculum Revisions

The following minor curriculum revisions were approved

Change in number for Accounting 440 to Accounting 456 Controllership (4)

Change in credit hours for History 357 and 358 from three to four credits each

Delete the following courses: COMS 375, Computer and Communication Systems of the Future; 445, Practicum II; 475, Future Information Technologies & Public Relations

Change in number for COMS 370 to 315

Change in prerequisites for the following COMS courses:

COMS 100 Add: May not be used in computer science major. May be used for minor if COMS 145 is not used.

COMS 140 Add: May not be used in computer science major.

COMS 145 Add: May not be used in computer science major. May be used for minor if COMS 100 is not used.

Decrease in number of credit hours for the following courses: SLHS 342 from 3 to 2 credits; SLHS 424 from 5 to 4 cr.; SLHS 422, from 4 to 3 cr. In conjunction with this particular reduction in credit, the course description will be adjusted by deleting the words "... and cerebral palsy..."

Increase in the number of credit hours for the following graduate seminars: SLPA 521 from 2 to 3 cr.; SLPA 522, from 2 to 3 cr.; SLPA 523, from 2 to 3 cr.; SLPA 525 from 2 to 3 cr.

Eliminate the credit differential between the 400 and 400G courses in SLHS: SLHS 401(g), 422(g), 444(g) changed to 3 cr. for both undergraduates and graduates
SLHS 423(g), 424(g), 447(g) changed to 4 cr. for both undergraduates and graduates

American Studies 317 and 419

J. Strong moved, O. Sharma seconded, to add the "g" designation for American Studies 317 and 419. Motion carried.

Swedish 101-102-103

D. Corrick moved, R. Bynum seconded, to approve Swedish 101-102-103, Beginning Swedish (4ea), including approval for Liberal Arts credit. Motion carried.

MDS 174

D. Corrick moved, W. Fischer seconded, to approve MDS 174, Writings from Where We Are (4) including approval for Liberal Arts credit in the Humanities area. Motion carried.

English 248

J. Strong moved, P. Joraanstad seconded, to approve English 248, Introduction to American Ethnic Literature (4) including approval for Liberal Arts credit. Motion carried.

Music 215

M. Kranz moved, R. Bynum seconded, to approve Music 215, History of Jazz, for Liberal Arts credit. Motion carried.

LART 525

D. Corrick moved, M. Kranz seconded, to approve LART 525, The Marxist Worldview (3-4 cr.) Motion carried.

Revisions in Elementary Education Major

D. Corrick moved, R. Bynum seconded, to approve the revisions in the curriculum for the Elementary Education Major, the proposed course revisions and the new course proposal Education 467, Practicum - Elementary Teaching (1-6 credits) Motion carried.

PE 111

J. Strong moved, R. Bynum seconded, to approve PE 111, Concepts of Physical Education (2). Motion carried.

PE 311

R. Bynum moved, M. Kranz seconded, to approve PE 311, Motor Learning (3). Motion carried.

Health 124

W. Fischer moved, D. Corrick seconded, to approve Health 124, First Aid--Elementary Education (1). S. Roy moved, J. Strong seconded, to amend that credit not be granted for both 124 and 125. Motion to amend carried. Motion to approve as amended carried.

Accounting Revisions

W. Fischer moved, R. Bynum seconded, to delete Acct 410, 450, 451, 455 and add the following new courses: Acct 340, Introduction to Federal Taxation (4); Acct 441(g), Individual Income Taxes (4); Acct 443, Taxation of Corporations and Partnerships (4); and approve requiring Acct 340 for the Accounting major in place of the present requirement of Acct 450 or 410. Motion carried.

History 214

J. Charon moved, J. Strong seconded, to table History 214 until the Liberal Arts Subcommittee has taken action on it. Motion to table carried.

History 240

W. Fischer moved, S. Roy seconded, to table and ask the department to provide a more complete outline and statement of objectives. Motion to table carried.

J. Strong moved, S. Roy seconded, to approve the offering of this course as a topics course for the fall of 1982 only. Motion carried.

Computer Science 410(g)

D. Corrick moved, W. Fischer seconded, to approve the "g" designation for COMS 410, Theory of Language Translation (4). Motion carried.

Request for Liberal Arts Credit

W. Fischer moved, D. Corrick seconded, to approve the following MDS courses for Liberal Arts credit for students enrolled in the New Center only: MDS 111, Expository Writing; MDS 132, Human Sexuality; MDS 180, Plants and Humans I; MDS 181, Plants and Humans II; MDS 185, Humans and Their Environment; MDS 190, Science of the Human Body; MDS 195, Astronomy; MDS 197, Natural Phenomena; MDS 220, Social Science Research & Writing; MDS 226, Athletics in the U.S.; MDS 227 Corporations: History, Structure, Influence; MDS 161, Introduction to Dramatic Art II; MDS 171, Comedy: A Mirror of Society; MDS 172, Science Fiction and Contemporary Values; MDS 110, Development Writing; MDS 112, Writing Research Papers; MDS 120, Mathematics II. Motion carried.

D. Corrick moved, J. Strong seconded, that the liberal arts designation not appear in the printed class schedule for courses offered for liberal arts credit for new center students only. Motion carried.
