#### Minor Curriculum Revisions

The following minor curriculum revisions were approved:

Change in title for Anthro 335 from Man, Culture and Environment  
to Humans, Culture and Environment

Change in title for Physics 106 from Man and Energy to Energy and Society

Change in title for MDS 180, 181 Plants and Man I and II to Plants and  
Humans I and II

Change in title for MDS 185 Man and His Environment to Humans and Their  
Environment

Change in number for MC 304 to MC 240, History of American Journalism

Drop "g" designation for the following courses: Finc 458, Mktg 441,  
Mgmt 420, 451, 455, and 460.

Reduce credits for MDS 130 from 5 to 4 credits.

Changes in Medical Technology Program: Change when courses will be  
offered during the year: (a) From Fall to Spring Biol 306, 350 and  
410, (b) From Spring to Fall Biol 470. Substitutions for two required  
courses: Biol 360 for Biol 302 and Chem 312 for Chem 222. Change  
recommended courses in Genetics from Biol 241 to Biol 341 with lab.

Drop the following requirement in Mass Communications: 35 credits of the  
52 required for the major must be at the 300 level or above.

#### History 240

S. Roy moved, M. Kranz seconded, to approve History 240, History of American  
Journalism (3). Motion carried.

#### Individualized Major - English as a Second Language

In accordance with APAC time guidelines, it was the consensus that this item  
be placed on the agenda in the fall.

#### Graduate Program Evaluations

J. Charon moved, D. Corrick seconded, to accept the Graduate Program reports  
and the evaluations and to discuss, in the fall, the implications for the  
entire university of dropping individual graduate programs. Motion carried.

#### Legal Assistant 250

O. Sharma moved, R. Bynum seconded, to approve Legal Assistant 250, Legal  
Research and Communication (4), with the instructors to be listed as: An

attorney and someone with at least a masters preparation in English or Business Education. Motion carried.

Education 559, 560, 561

J. Strong moved, J. Tesch seconded, to approve Education 559, Higher Education: A System Overview (3); 560, The Organization of Student Personnel Services (3); 561, The College Student (3). Motion carried.

Proposal from Subcommittee on Writing

J. Charon moved, J. Tesch seconded, to table the proposal from the Subcommittee on Writing until fall and to schedule some hearings of the entire faculty on these proposals. Motion to table carried.

It was agreed that in the meantime the subcommittee will initiate a survey of departments, use the findings of the survey to make changes in the proposal, allow time for departments to respond, and then to submit the proposal to a hearing process before APAC takes action.

Subcommittee on Size of Majors

R. Badal distributed a progress report from the Subcommittee on Size of Majors This report will also be distributed to all department chairs.
