Minutes of Academic Policy Advisory Council Tuesday, November 16, 1982 Members Present: W. Jones, Chair; R. Bynum, E. Clark, D. Engberg, W. Fischer, W. Harri, M. Kranz, M. Legg, B. McCashland, D. Meinke, N. Parlin, K. Powell, M. Pryor, S. Roy, J. Strong Minor Curriculum Revisions The following minor curriculum revisions were approved: Change in titles for the following MCS courses to read as follows: MCS 101, Afro-American Experience MCS 211, Contemporary Afro-American Community MCS 301, Afro-American Music MCS 311, Afro-American Art MCS 321-322, Afro-American Lit I and II MCS 451, SEM: Afro-American MCS 461, RDG: Afro-American Change the prerequisite for PE 421(g), Physiology of Exercise to: PE 220, PE 321, or consent of instructor. AAC recommendation regarding Graduate Programs M. Pryor moved, K. Powell seconded, that we suspend the programs M.S. in English Ed., Physical Ed., Social Studies Ed., and that we postpone action for a year on Chemistry Ed. W. Harri moved, W. Fischer seconded, to table this motion. Motion carried. Recommendations from Subcommittee on Size of Majors D. Engberg moved, W. Fischer seconded, the adoption of the following recommendation: that the APAC chair should appoint an ad hoc subcommittee, drawn from the current membership of APAC, for the purpose of thoroughly evaluating the individualized major program. Motion carried. M. Pryor moved, R. Bynum seconded, that the chair of APAC circulate to departments the survey prepared by the subcommittee. Motion carried. R. Badal asked that it be noted that in the report from the Subcommittee in the table of data, under the program heading Social Studies, the total degree requirements should be listed as 84 credits. Procedure for Major Policy Changes K. Powell moved, R. Bynum seconded, that procedures for major policy changes be as follows: A summary of the major policy revision will be listed in the published APAC agenda and the first meeting to discuss the item will be considered a hearing and the APAC meeting two weeks later will be the earliest that action can be taken. Motion carried. S. Ferris
