Minor Curriculum Revisions

J. Strong moved, K. Powell seconded, to table action on LART 306. Motion to table carried.

The following minor curriculum revisions were approved:

Phil 210, Philosophy and Women, 4 credits, (topics course) approved for LA designation for Spring Quarter, 1983.

Change in credits for SpEd 425 from 3 to 4 credits with the understanding that students will not be required to enroll concurrently in SpEd 436 (1 cr.)

Tabled Motion Regarding Graduate Programs

- K. Powell moved, M. Pryor seconded, to remove the following motion from the table: To suspend the programs M.S. in English Ed., Physical Ed., Social Studies Ed., and that action be postponed for a year on the M.S. in Chem. Ed. Motion to remove from the table carried. K. Powell moved, W. Fischer seconded, to divide the question. Motion carried.
- D. Engberg moved, J. Strong seconded, to suspend the M.S. in English Ed. Motion carried.
- J. Strong moved, K. Powell seconded, to suspend the M.S. in Physical Ed. Motion carried.
- K. Powell moved, E. Clark seconded, to table action on the M.S. in Social Studies Ed. in order to allow the departments involved to bring forth a proposal by January 1, outlining what the program would look like with only two departments cooperating and APAC would take action on the proposal. Motion carried.
- J. Strong moved, W. Harri seconded, to postpone action on the M.S. in Chem. Ed. for one year. Motion carried.

MCS 311

W. Harri moved, M. Kranz seconded, to approve MCS 311, Afro-American Art (3) including LA designation. Motion carried.

T.ART 305

D. Engberg moved, K. Powell seconded, to approve LART 305, Human Rights (4), including LA designation. Motion carried.

Phil. 211

- J. Strong moved, K. Powell seconded, to approve Phil 211, Morals and Medicine, 2-4 cr., (2 credits designated toward LA).
- K. Powell moved, M. Legg seconded, to table the proposal and ask the LART Subcommittee to inform APAC of the reasons for giving two credits of LA credit instead of 4 or to propose a method to facilitate record-keeping. Motion carried.
