Minor Curriculum Revisions

The following minor curriculum revisions were approved:

Cross-list English 290, Intro. to American Indian Literature with
MCS 300 (includes LA designation for Summer 1983 only).

Liberal Arts designation for Engl 380, Modern European Fiction (Spring '83
only)

Philosophy 211

M. Legg moved, K. Powell seconded, to approve Philosophy 211, Morals and Medicine
2-4 credits, including liberal arts designation (humanities). Motion carried.

Philosophy 215

W. Harri moved, K. Powell seconded, to approve Philosophy 215, Animal Rights (2),
including Liberal Arts designation (humanities). Motion carried.

Psychology 570

J. Strong moved, R. Bynum seconded, to approve Psychology 570, Advanced Psychological
Testing: Personality (3). Motion carried.

LART 308

M. Kranz moved, M. Legg seconded, to approve LART 308, The Third World Experience
in its Literature (4), including liberal arts designation (humanities). Motion
carried.

Economics Minor

W. Fischer moved, W. Harri seconded, to approve the proposed revisions in the Economics
minor. Motion carried. The revised minor is approved as follows:

Econ 202-204-206, Principles of Economics I-II-III (12)
Any two of the following three: Econ 302, Intermediate Microeconomic
Theory (4); Econ 304, Intermediate Macroeconomic Theory (4); Econ 317,
History of Economic Thought (4).

Econ 390, Introduction to Economic Literature and Methodology (3)

An additional eight (8) credits of approved electives in economics.

Total 31 credits.

Music Department Curriculum Revisions

W. Fischer moved, W. Harri seconded, to approve the option of expanded credit for
upper division applied lessons: Music 350, 355, 360, 365, 366, 367, 368, 450, 455,
460, 465, 466, 467 and 468 changed from 1-2 to 1-3 credits. Motion carried.

K. Powell moved, J. Strong seconded, to table the changes in the diction courses and
requested that the changes be stipulated on the APAC agenda for the next meeting. Motion
carried.

J. Strong moved, R. Bynum seconded, to approve the change in credits for Music 204,
Individual Projects, from 2 credits to a variable 1-2 credits. *Motion carried.*
