#### Minor Curriculum Revisions

Addition to minor curriculum revisions approved at January 25 meeting: Approve Liberal Arts Interdivisional designation for LART 301 War and Peace (4).

The following minor curriculum revisions were approved:

Change in title for Sociology 307 to Sociology ~~(6)~~ the Criminal Court

Change in title for Econ 206 Principles III: Compar to Principles III:  
International

Change in title for IndS 250 from General Graphic Arts to Explorations in  
Graphic Communications

#### Revisions in Sociology Major and Minor

K. Powell moved, J. Strong seconded, to approve the revisions in the Sociology major and minor. Motion carried. The revised requirements are listed below.

Sociology major requirements: Option B dropped.

Revised major requirements: Soc. 310, Majority-Minority Relations, added. All required courses for major: 110, 111, 112, 205, 211, 310<sup>3/2</sup>, 350, 351, 411, plus 27 credits electives (12 credits may be in Anthropology and 8 credits may be in Soc. 469, Internship). The total credits required are still 63.

Sociology minor: Soc. 112 dropped as a requirement; 211, 310, 350, added. Total required hours increased from 33 to 36. All required courses: 110, 111, 211, 310, 350, plus 16 credits of electives in Sociology.

#### Humanities 217

M Legg moved, K. Powell seconded, to table Humanities 217 and request opinions from the departments of English and Languages. Motion to table carried.

J. Strong moved, W. Fischer seconded, to request that K. Powell and R. Bynum propose a procedure to request information, to be included with new course proposals, regarding duplication. Motion carried.

#### Humanities 227

M. Pryor moved, K. Powell seconded, to table Humanities 227 for the purpose of allowing time to consult with the English Department. Motion to table carried.

#### Humanities 312(g)

K. Powell moved, M. Kranz seconded, to approve Humanities 312(g) Women and the Humanities (4). Motion carried.

Ind. Studies 381, 382, 383

J. Strong moved, W. Fischer seconded, to approve IndS 381, Plant Layout and Materials Handling; 382, Time and Motion Studies (3); 383, Manufacturing Quality Control (3). Motion carried.
