Minutes of Academic Policy Advisory Council Tuesday, March 15, 1983

Minor Curriculum Revisions

The following minor curriculum revisions were approved:

Change in title for Sp. Ed. 592 to Administration and Supervision of Reading Instruction

Add (g) designation to Ed. 375, Theories of Instruction for Young Children Change in number from Engl. 493(g) to 363(g) and from 491(g) to 361(g)

Master of Science in Social Studies Education

D. Engberg moved, W. Fischer seconded, to remove from the table the proposal to suspend the M.S. in Social Studies Education. Motion carried.

D. Engberg moved, M. Legg seconded, to place this item on the agenda for the next meeting of APAC. Motion carried.

MDS 104

J. Strong moved, W. Fischer seconded, to approve MDS 104, Issues and Evaluations, including liberal arts designation (4 credits social sciences, 1 credit humanities). Motion carried with two opposed.

Change in Math 090

W. Fischer moved, E. Clark seconded, to approve the change in course number from Math 090 to 111, and to change the catalog description by deleting the statement "Credit not applicable to degree" and add "Prerequisite: Consent of instructor". It was agreed that a statement be included "Not open to students having completed Math 121 or above." Motion carried with one opposed.

COMS 110

R. Bynum moved, W. Fischer seconded, to table the proposal from the Computer Science department. Motion to table carried.

Department of Industrial Studies - Curriculum Proposal for Construction Management Concentration

The curriculum proposal and new course proposals were discussed. It was agreed that these items would be placed on the agenda for the next meeting.

Education Department Curriculum Revisions

- J. Strong moved, R. Bynum seconded, to approve Ed. 522, Perception, Language and Reading (3). Motion carried. R. Bynum moved, W. Fischer seconded, to approve Ed. 524, Seminar in Reading (3). Motion carried.
- W. Fischer moved, R. Bynum seconded, to approve the change in title from Master of Science--Remedial Reading to Master of Science--Reading and the proposed revisions in requirements. Motion carried.

Report from Subcommittee on Individualized Majors

There was discussion regarding the report from the Subcommittee on Individualized Majors. W. Fischer moved, D. Engberg seconded, to table the recommendations for further discussion at the next meeting. It was agreed that the four recommendations from the subcommittee would be listed in the agenda. Motion to table carried.

J. Strong moved, M. Pryor seconded, to list on the next agenda the recommendation to abolish subtitles for individualized majors. Motion carried.
