Minutes of Academic Policy Advisory Council Tuesday, October 18, 1983

Minor Curriculum Revisions The following minor curriculum revisions were approved:

Change number for Ed 411(g) to Ed 410(g) Counseling in the Helping Professions (3).

Change number for Ed 410(g) to Ed 411(g) Basic Counceling Skills (3).

Change in "Related Area Requirements" for Office Administration major from ComS 100 Computers and Society (4) to ComS 120, Computers and Society (2).

Change in "Business Education Requirements" for Office Administration major: Add BE 260 Micro Computers in Business (3).

Revision in Art Ed Curriculum Change Art 440 from 4 to 3 credits Change Art 442 from 3 to 2 credits Drop Art 454(g) Change name of Art 455(g) to Practicum for BFA degree

Cross list Industrial Studies 424, Soils and Foundations as Engineering 424.

### Art 441, 443, 444

K. Smemo moved, W. Peck seconded to approve Art 441, Practicum in Art Education (7-12), 1 credit; Art 443, Practicum in Art Education (K-6) 1 credit. Motion carried. S. Roy moved to table Art 444, Creative Crafts until the Art Department has shown this proposal to the Industrial Studies department. It was recommended that the number be changed to 200 level. Motion to table carried.

#### Revision in Industrial Chemistry Major

E. Clark moved, R. Bynum seconded, to approve the revisions in the Industrial Chemistry major. Motion carried. D. Cole moved, R. Bynum seconded, to approve the following new course proposals:

Chemistry 401, 402, 403, Applied Chemistry Lab I, II, III, 2, 1, 1. Chemistry 491, Cooperative Education in Chemistry, 8, 6 and 4 for three periods of 10-12 weeks each.
