The following minor curriculum revisions were approved:

Change the course description of MBA 529 to: MBA Corporate Financial reporting (4). Study of financial reporting practices and principles, including professional pronouncements. Analysis and interpretation of corporate financial reports. Prerequisites: Acct 229-230. May not be taken for credit by students who have taken Acct 480.

Drop MBA 504 as a prerequisite for MBA 510 and add MBA 502.

Change title of Anthropology 111 to Evolution and Prehistory
Change title of Anthropology 350 to Psychological Anthropology
