Social Work 440

W. Harri moved, R. Hadfield seconded to approve dividing Social Work 440 into SW 369, Field Experience I (4-8) and 479, Field Experience II (4-15). Motion carried.

Minor Curriculum Revisions

A. Behforooz moved, W. Harri seconded, to approve the following minor revisions:

Change title of SLHS 542 to Augmentative and Alternative Communication.

Combine the lecture sections with the lab sections for Physics 111-112-113.

Motion carried.

Math 383(g)

P. Hansen moved, A. Behforooz seconded, to approve Math 383(g), Applied Regression Analysis (4). It was agreed that Math 274 would be deleted under the prerequisites. Motion carried.

Change in Criminal Justice Major Requirements

W. Wesley moved, R. Bolton seconded, to approve the Revisions in the Criminal Justice Major requirements. Motion carried.

Proposal for a Major in Cytotechnology

The proposal for a Major in Cytotechnology (B.S. degree) was discussed.

Graduate Council Recommendation

W. Harri moved, P. Hansen seconded, to remove from the table the Graduate Council recommendation. Motion to remove from the table carried.

W. Harri moved, J. Stevens seconded, to approve the recommended policy: Graduate students who obtain a C or lower grade in a graduate course may re-register and repeat the course one time. The grades in both courses will count in computing the grade point average.

J. Stevens moved, P. Hansen seconded, to amend the motion as follows: Graduate students who obtain a C or lower grade in a specifically required graduate course may re-register and repeat the course one time. The grades in both course attempts will count in computing the grade point average. Amendment passed 7-5.

A. Behforooz moved, B. Midgarden seconded, to table the amended motion. Motion to table carried.
