Changes in Requirements from Related Fields for a Social Work Major

J. Stevens moved, R. Bolton seconded to approve changes in requirements from related fields for a social work major. Motion carried. Changes were approved as follows:

J. Stevens moved, D. Corrick seconded, to approve proposal for a Major in Cytotechology. Motion carried.

Tabled Motion: Graduate Students Repeat Courses with "C" Grade

- A. Behforooz moved, R. Dahlke seconded, to substitute motion as follows: Graduate students will be allowed to repeat a course in which they have received a grade of "C" or lower. Rules of G.P.A. computation will apply as they presently exist for undergraduate courses. Motion to substitute carried.
- D. Corrick moved to amend substitute motion: grades in all attempts will be used to compute G.P.A. Motion to amend died for lack of second.
- A. Behforooz moved, R. Dahlke seconded, to approve substitute motion. Motion failed.

MDS 107, Human Development and Growth in the Modern World (4)

P. Hansen moved, W. Wesley seconded, to approve MDS 107, Human Development and Growth in the Modern World, including liberal arts designation (Division C). Motion carried.

MC 460 (g), International Communication (4)

S. Roy moved, Ruth Dahlke seconded, to approve MC 460 amended as follows: change total class meeting hours per quarter or session from 35 to 40, and change the word "Communist" to "Marxist" in the official catalog description. Motion carried.
