Revision in Medical Technology

W. Harri moved, L. Bakke seconded, to approve the revision of the Mathematics requirement in the Medical Technology Major requirement as follows:

Math Requirement - 8 credits or equivalency

Math 274 or Math 375 and one of the following:

the achievement of a B average in 3 years of high school math and ACT, SAT, or PSAT score above the 75th percentile,

any other college mathematics course at or above the level of Math 121 (Int. Algebra), including credit by CLEP subject examination (MSU Math 100 110, and 111 or equivalent transfer courses may NOT be applied to satisfy this requirement).

Motion carried.

German, French, Spanish, Norwegian 107-108

D. Corrick moved, A. Behforooz seconded, to remove from the table the proposal from the Language Department. Motion carried.

D. Corrick moved, J. Stevens seconded, to approve German, French, Spanish, Norwegian 107-108, including LA designation (Division E), with an added statement on the course description: Credit not given for both 101, 102, 103 and the 107-108 sequence. Motion carried.
