E. Alberts moved, J. Barnett seconded, to let original motion (to approve) stand. Motion carried.

Bus. Admin. Policy Regarding "D" Grade

W. Vollmers moved, E. Alberts seconded, to approve the proposed Business Administration departmental policy: Effective Fall, 1989, a "D" grade will no longer be accepted to satisfy courses in the Business Core and Major requirements. Motion carried.

Social Work

E. Alberts moved, M. Moore seconded, to approve the revisions in Social Work. Motion carried.

Criminal Justice Revision

M. Pehler moved, T. Schaum seconded, to approve the Criminal Justice revision: At least three courses must be on single component of the criminal justice system. Motion carried.

English Department Revisions
