Astronomy

Margaret Moore moved, W. Vollmers seconded, to approve the amended course description of Ast 100L, Introductory Astronomy Laboratory (1):

Observational work in astronomy. The course involves acquisition and analysis of data acquired from observation of celestial objects as well as of data gathered in the laboratory. The course will include observation of celestial motions, study of lunar surface features, spectroscopy, and radioactive decay.

Motion carried unanimously.

Social Work

The cross listing of SW 403, Health Care Issues and Services and SW 409, Social Policies and Services for the Elderly with Sociology 403 and 409 was approved. Motion carried 5-4.

Energy Management

Molly Moore moved, Margaret Moore seconded, to approve the changes in course requirements for Energy Management majors:

Drop EMgt 300: Geology of Energy Resources as a required course (4 credits). This course will still be available as an elective course.

Add Biology 103: Humanity and the Ecosystem (4 credits)

Motion carried unanimously.

Molly Moore moved, T. Schaum seconded, to approve discontinuation of Recreation and Leisure Studies major. Motion carried unanimously.

Education

Margaret Moore moved, M. Hansel seconded, to approve the proposed new Education courses and the changes in Ed 447(g).

The credits for Ed 447(g) Reading Workshop will be listed as 1-2 credits and the new description is: "Designed for reading teacher to update theories and practices in teaching reading. Topics will vary as offered."

Motion carried unanimously.
