L. Bakke moved, W. Vollmers seconded, to approve the revisions in
Psychology as follows:

PSY 550, Advanced Psychological Testing: Personality and PSY 552,
Individual and Group Intervention Techniques. The School
Psychology Coordinating Committee (SPCC) and the Psychology
Department request that the credits for these courses be listed as
variable (1-3) and that the following statement be added to the
prerequisite section of the catalogue description: "May be
repeated to a maximum of 3 credits."

PSY 506, Practicum in School Psychological Services II. The SPCC
and the Psychology Department request that the credits for this
course be made variable (1-5) and that the prerequisite statement
be changed to read: "PSY 505 and consent of instructor. May be
repeated to a maximum of 5 credits."
