T. Gracyk moved, P. Beare seconded, to approve the minor changes in Health, Physical Education and Recreation. Motion carried unanimously.

C. Brown moved, P. Beare seconded, to approve PE 195, Activities Course - Block V (2). Motion carried unanimously.

Biology

S. Roy moved, T. Gracyk seconded, to approve the minor changes in proposal B, C, D and E in Biology. Motion passed unanimously.
