APAC Minutes

May 7, 1991

Legal Assistant Program Revisions

Moore moved, Brown seconded, to approve LegA 335, Personal Injury (4) and LegA 340, Evidence (4). Motion carried unanimously.

Zarrett moved, Moore seconded, to approve adding BEd 260 as a related requirement in the Legal Assistant Program. Motion carried unanimously.

Bakke moved, Moore seconded, to approve the division of the Litigation track into two tracks: Civil Litigation and Criminal Litigation and to approve the revisions in the Real Estate track. Motion carried unanimously.

Termination of the Vocational Rehabilitation Therapy Program

DeMaio moved, Bakke seconded, to terminate the Vocational Rehabilitation Therapy Program. Motion carried unanimously.

School Psychology Curriculum Changes

Beare moved, Moore seconded, to refer the School Psychology Curriculum changes back to the department for consultations with other units. Motion carried 6-3.

Biology 241

Bakke moved, Wolff seconded, to remove Biology 241 from the table. Motion carried.

DeMaio moved, Brown seconded, to approve the change in credits from 3 to 4 for Biology 241 including LA designation (Division B). Motion carried unanimously.

German & French

Moore moved, Bakke seconded, to approve the revisions in German and French. Motion carried with one opposed.

French & Spanish

Moore moved, DeMaio seconded, to approve the revisions in French and Spanish. Motion carried with one opposed.

Chinese 397

Bakke moved, DeMaio seconded, to approve Chinese 397, Independent Study in Chinese - Advanced Level I (1-4). Motion carried unanimously.

Grade Appeal Process

Barden will appoint a subcommittee of APAC to review the proposed Grade Appeal Process. The subcommittee will report back to APAC during the next academic year.

CS 400-Level "g" courses

DeMaio moved, Alvarez seconded, to approve the revisions in titles and descriptions for the CS 400-level "g" courses. Motion carried unanimously.
