Philosophy Prerequisite Revisions

Gracyk moved, Bakke seconded, to approve the following Philosophy changes in prerequisites:

Prerequisite for Philosophy 300, 301, 304, 305, 320, 350, 355, 360, 365, 370, 380 be changed to read "One Philosophy course approved for Liberal Studies Division D (Western Tradition), or consent of instructor.

Motion carried unanimously.

#### **HPER**

Alberts moved, Moore seconded, to approve the following revisions in HPER: Delete the prerequisites for PE 194 Activity IV. Add 8 credits of activity classes as a prerequisite for PE 243. Motion carried unanimously.

## Music 550-568

Gracyk moved, Engels seconded to approve changing the credits for Music 550-568 from 1 to 2 to 1 to 3. Motion carried unanimously.

#### Soc 414

Engels moved, Alberts seconded, to approve Soc 414, Seminar: Symbolic Interactionism (4). Motion carried unanimously.

## Physics 311

Moore moved, Bakke seconded, to approve Phys 311, Introduction to Circuit Analysis (5). The proposal to drop Physics 340 will be forthcoming this academic year. This is a course proposal that, in part, has been proposed because of the conflict in academic calendars between MSU and NDSU. Motion carried unanimously.

Alberts moved, Gracyk seconded, to approve the curriculum revisions in Industrial Technology and the following new course proposals:
