#### <u>Math 121</u>

Alberts moved, Gracyk seconded, to approve changing Math 121 (4) to Math 099 (no credit) and adding to the course description "Not applicable to degree. " Motion carried unanimously.

Gracyk moved, Alberts seconded, to approve Honors 305, Good and Evil in Literature (4). Motion carried unanimously.

### Engl 240

Gracyk moved, Engels seconded, to approve Engl 240, Future in Fiction (4) for Liberal Studies Designation for Spring Quarter, 1993, only. Motion carried unanimously.
