Middle School Licensure Program

The hearing phase for the Middle School Licensure program was completed; this item will be placed on the next agenda.

Art 489

Moore moved, Bakke seconded, to approve Art 489, Women and Art (4) for Liberal Studies designation Division D, for a one-time Continuing Education offering. Motion carried unanimously.

Art Curriculum Revisions

Moore moved, Engels seconded, to approve the revisions in the Art curriculum. Engels moved, Gracyk seconded, to table and asked that the department clarify the number of class hours required. Motion to table carried unanimously.

Elementary & Early Childhood Education Curriculum Revisions

Gracyk moved, McGahey seconded, to approve the following multiple criteria for admission to Elementary and Early Childhood Programs:

1. GPA minimum of 2.75 overall and GPA of 2.25 in liberal studies.
2. Completion of 80 credits prior to applying for admission.
3. A passing score on the essay prior to admission to the program.
4. Approval of the faculty based on the interview and portfolio in progress.
5. Prior experience with children to adolescents.
6. Verification from supervisor of prior experience with children/adolescents.

If there are more students who are eligible for admission to the program than we can accommodate, preference will be given to those who have the highest number of total points.

Two years after the start of this requirement, the department should report to APAC on how the procedure is working.

Motion carried unanimously.

Engels moved, Bakke seconded, to drop the graduate designation for ELEC 441, Children's Literature and ELEC 448, Reading Study Skills in the Content Areas. Motion carried unanimously.

Gracyk moved, Walker seconded, to approve ELEC 430(g),  
Administration of Early Childhood Education Programs (4). Motion  
carried unanimously.

Beare moved, Olday seconded, to approve ELEC 435(g),  
Parent-School Relations (4). Motion carried unanimously.

Walker moved, Gracyk seconded, to approve ELEC 477, Seminar in  
Early Childhood Education (1). Motion carried unanimously.

Engels moved, Peil seconded, to approve ELEC 488(g), Issues in  
Early Childhood (3). Motion carried unanimously.

Bakke moved, Peil seconded, to approve ELEC 550, Science:  
Elementary School (3). Motion carried unanimously.
