- Art 156 Change (2-4) credits to 4 credits
- Art 157 Change (1-4) credits to 4 credits
- Art 160 Change 3 credits to 4 credits
- Art 220 Change 3 credits to 4 credits
- Art 252, 253 Change 3 credits to 4 credits
- Art 268 Change 3 credits to 4 credits. "Glass
Construction"
- Art 391 Change to: "Contemporary Art; Form and Content"
- Art 449 Change 3 credits to 4 credits.

Drop the following courses: Art 114, 123, 124, 175,
271, 272, 437, 439.

Motion to approve art curriculum revisions carried unanimously.

Gracyk moved, Bakke seconded, to approve the revised minor in
Art (B.A. degree). Motion carried unanimously.

WS 222

Gracyk moved, Engels seconded to approve WS 222, Practicum in
Women's Studies (2-8). Gracyk moved, Beare seconded, to table
WS 222, Practicum in Women's Studies (2-8) and asked that S.
Coghill get departmental responses to the proposal (those
listed on the proposal and SLHS and perhaps others) and to
provide clarification on how this would differ from Social Work
practicum. Motion to table carried unanimously.

Lang/Hum 132

Moore moved, Gracyk seconded, to approve Lang/Hum 132,
Introduction to Chinese Culture (4), including Liberal Studies
designation Division F. Motion carried unanimously.

Elem Ed Revisions in Core Requirements

Beare moved, Bakke seconded, to approve the revisions in the core requirements in Group 2 and Group 3 in the Master of Elementary and Early Childhood program. Motion carried unanimously.

Anthropology 380

McGahey moved, Olday seconded, to approve Anthropology 380, Traditional Cultures (4), including Liberal Studies designation Division F. Motion carried unanimously.

Revisions in Anthropology Major

Walker moved, Molly Moore seconded, to approve the revision in the Anthropology major: Drop Anthropology 401-402-403 as requirements for the major and substitute Anthropology 445 as a requirement in the major and to approve the major with 60 credits instead of 59. Motion carried unanimously.

Archaeology Concentration

The hearing on the option for a concentration in archaeology in the anthropology major was completed; this item will be on the next agenda.
