MDS 109

DeMaio moved, Bakke seconded, to approve the change in title for MDS 109 to Introduction to Higher Education (2). Motion carried unanimously.

MDS 178

Gracyk moved, Engels seconded, to approve MDS 178, Reading Multicultural Literature (4) including Liberal Studies designation Division F. This course does not meet the specific objectives of cultural diversity. Motion carried unanimously.

Archaeology Concentration

Walker moved, Papenfuss seconded, to approve a concentration in archaeology in the anthropology major. Motion carried unanimously.

Music 216

McGahey moved, Engels seconded, to approve Music 216, World Music Survey (4) including Liberal Studies designation Division F. A revision is to be made to the course proposal form under prerequisites by replacing "or" by "and." (Prerequisite will read: MUS 211, and sophomore standing, or consent of the instructor.) This course does not meet the specific objectives of cultural diversity. Motion carried unanimously.

English 395

Engels moved, Beare seconded, to approve English 395, Theory and Methods of Tutoring (4). DeMaio moved to table, Bakke seconded, and the motion to table carried unanimously. This item will be on the next agenda.

Honors 306

Gracyk moved, DeMaio seconded, to approve Honors 306, Human Nature in the Western Tradition (4). APAC requested copies of the memos of departmental support for the course from philosophy and psychology, and referred the proposal to the Honors Committee for discussion and comment at its 4/7 meeting. Walker moved to table, Bakke seconded, and the motion to table carried unanimously. This item will be on the next agenda.

INDS 230, 231, and 232/ENG 230, 231, and 232

Engels moved, Walker seconded, to approve the co-listing of Industrial Studies 230, 231, and 232 with Engineering 230, 231 and 232, respectively. Motion carried unanimously.
