Moore moved, Papenfuss seconded, to approve Ed 482(g), Information Technology for Teachers (3). Motion carried unanimously.

Music 337(g)

Engels moved, Bakke seconded, to approve <sup>the curriculum revisions</sup> the change ~~in~~ title for Music 337(g) to Vocal Jazz Ensemble. Motion carried unanimously.

SpEd Curriculum Revisions

Gracyk moved, Engels seconded, to approve the revisions in the Special Education curriculum. Motion carried unanimously.

MFA in Creative Writing

McGahey moved, Walker seconded, to approve the proposal for a Master of Fine Arts in Creative Writing. Motion carried unanimously.

Biology 301

Gracyk moved, Walker seconded, to approve the change in title and description for Biology 301 to Developmental Biology: A study of the mechanisms of development in a variety of biological systems, with analyses of changes from conception through aging. With lab. Prerequisite: Biol. 113 (Biol. 341 recommended). Motion carried unanimously.

Dropping Courses from Master List

DeMaio moved, Pratt seconded, to drop the proposed courses (copy attached) from the master course list with the exception of Mgmt 594. Motion carried unanimously.

Liberal Studies Upper Division Graduation Requirements

Olday moved, McGahey seconded, to approve the following subcommittee recommendation: The APAC Subcommittee recommends that the policy concerning implementation of the Upper Division Graduation requirement (English 300) be stated as follows: Advisors should permit students to fulfill the English 300 requirement only after achieving junior standing. Motion carried unanimously.

Mission Statement
