APAC Minutes November 8, 1994

1. Semester Conversion: Department of Computer Science and Information Systems.

John Gaffrey, Chair of the CSIS department, distributed materials to members stating the following modifications made to the CSIS semester conversion package:

1. Remove COMS 330 from the proposal.
Remove Math 225 from the related requirements for the COMS major.
Remove the COMS 330 and/or Math 225 prerequisites for the following courses:

COMS 435/535: Compilers

COMS 632: Automata Theory and formal Languages

COMS 634: Algorithm Analysis

Rationale:

We would like more time to develop a sequence in the FOUNDATIONS OF COMPUTER SCIENCE which will include essential topics specified in the ACM curriculum guidelines. We will bring this to APAC when it is complete. Appropriate prerequisites for the above courses will be specified after we have developed this sequence.

- 2. Change Accounting 130 to 230 for related requirements in the CIS major.
- 3. Include Accounting 230 and Management 360 as related requirements for the CIS minor.

COMS 330: Analysis and Design of Algorithms (3 semester cr.) The Computer Science department decided to remove this course from the semester conversion package.

Geol 102: Geology in the National Parks (4 quarter cr./3 semester cr.)
