APAC Minutes December 20, 1994

1. OTA Project Update

The order of the agenda was revised and Jan Flagel, Director of External Studies, reported on the Older-Than-Average Pilot Project. The OTA Pilot Project was requested by the Enrollment Management Task Force in the Spring of 1994 and approved by President Barden. The project was set up to allow 50 students, who did not meet the regular admission requirements, to be admitted into MSU Winter quarter of 1994/95. The plan entailed testing those students on their reading, writing and math skills and advising them in appropriate starting classes. Twenty-five faculty and staff were trained to administer tests, and in the fall, 13 students were admitted. Currently 11 students are enrolled in classes winter quarter and one student chose to wait until spring to take classes. At the end of winter quarter, feedback from the students will be gathered and will be used to evaluate the project.

Our request is to extend the OTA project into Spring quarter to enable the student evaluation pool to be larger. The project will be advertised through personnel offices and community service groups and hopefully more students will enroll in this project for spring quarter. The cap for enrollment into this program is set at 50 students.
