**APAC Minutes**  
**January 10, 1995**

MCS 372/PHIL 272: Dynamics of Prejudice & Oppression

Theodore Gracyk, Chair of the Philosophy department, submitted a memo to APAC regarding the changes made to this course. They are:

1. Renumber as PHIL 372
2. Reword the course description, adding the following at the end: No more than 2 credits to be applied to the Philosophy Major.

Dieter Berninger, Chair of the Humanities/Multicultural Studies department, submitted a memo agreeing to the changes.

Sue Cataldi distributed a new course proposal and a bibliography for this course to committee members for review. The new course title is:

MCS 372/PHIL 372: Dynamics of Prejudice & Oppression  
(4 semester cr.)

Bakke moved. Moore seconded to remove this course from the table for approval.

4. **Semester Conversion: Department of English**  
(two courses tabled at the 11/29/94 APAC meeting)

ENGL 288: Introduction to Creative Writing (3 semester cr.)

Alan Davis, Chair of the English department, submitted a new course proposal reducing the credits from 4 to 3. This course was approved for Liberal Studies designation E.

Roy moved. Bakke seconded to approve this course  
Motion carried unanimously.

ENGL 314: Topics in Shakespeare (3 semester cr.)  
(The Liberal Studies Committee approved this course for Division D1 credit, provided that it can not be repeated for liberal studies credit.)

Alan Davis, English Department Chair, submitted a new course proposal reducing the credits from 4 to 3. The course will carry Liberal Studies credit for Division D1. It will be repeatable once for majors when content varies significantly. The course title abbreviation will reflect these topics:

Shakes:Comedies; Shakes:Trag/Hist; Shakes:The Canon

Roy moved. Bakke seconded to remove this course from the table for approval with the following statement added to the course description:

May not be repeated for Liberal Studies credit

Motion carried unanimously.

**5. Semester Conversion: Department of Health and Physical Education**

(three PE courses and the Fitness and Sport Science Concentration in the PE major were tabled at the 11/29/94 APAC meeting)

PE 364: Teaching Aerobic Dance (3 semester cr.)  
PE 365: Health/Fitness Instructor (3 semester cr.)  
PE 473: Exercise Testing and Interpretation (3 semester cr.)

The HPE department submitted a memo clarifying the course content to the committee. All three courses carry the following laboratory and non-laboratory hours:

Non-laboratory hours per week = 3  
Laboratory hours per week = 0

Bakke moved. Correnti seconded to remove the three courses and the Fitness and Sport Science Concentration in the PE major from the table for approval.

Motion to approve each of the courses carried unanimously.

**Approval of the Fitness and Sport Science Concentration**

Pemle moved. Sibley seconded to approve.

Motion carried unanimously.



**6. MFA in Creative Writing: Preliminary Hearing**

The MFA proposal was initially approved one and a half years ago by the Graduate Council, APAC Committee and the State University Board. The proposal did not meet HECB approval however, and was returned for modification.

APAC's preliminary hearing is primarily to review and generate feedback on revisions needed before the final hearing at which time the committee will act on the proposal. The State University Board must receive the revised proposal by their February, 1995 meeting and, if approved, the proposal will move on for approval by the HECB; if these deadlines are not met, the proposal will have to wait and be submitted to the new MnSCU Board.

Thom Tamaro reported that the Graduate Council met on 1/9/95 and made suggestions for change and approved the proposal based on those changes.

The committee discussed the revisions needed. Alan Davis, Mark Vinz, Sheila Coghill and Thom Tamaro will integrate those changes into the proposal and APAC will act on it at the next meeting.

Meeting adjourned at 6:15 p.m.
