1. Academic Policy Changes under Semester Conversion
Action was delayed on this item pending revisions from the
Liberal Studies Committee.

Sam Roy asked for clarification of the Criminal Justice waiver approved at the 1/24/95 meeting. Elizabeth Danielson will bring clarification to the next meeting.

2. Semester Conversion: Department of Secondary Education (one of the two courses tabled at the 11/15/94 APAC meeting)

ED 205: Exploring Teaching 3 semester cr.

Mathiason moved. Moore seconded to remove this course from the table for approval.

This course was tabled because the committee wanted the Secondary Education department to contact departments with teaching majors to request written responses/comments regarding this course before re-submitting it to APAC. Steve Grineski, Secondary Education and Foundations department chair, complied with that request and found no concerns amongst the departments contacted. The course will carry two credits for course content and one credit for the lab experience. The course will be listed as:

ED 205: Exploring Teaching (2 semester cr.)
ED 205L: Laboratory experience (1 semester cr.)

MDS 290: Topics in Multidisciplinary Studies (1-3 semester cr. Bakke moved. Sibley seconded to approve the course with the following added to the catalog description:

MUS 228: Tri-College Percussion Ensemble (1 semester cr.) The Liberal Studies Committee approved this course for D designation.

Bakke moved. Sibley seconded to approve. Motion carried unanimously.

MUS 250: Jazz Improvisation (1 semester cr. Bakke moved. Correnti seconded to approve. Motion carried unanimously.

MUS 155C: Harpsichord (1-2 semester cr.)
Wasson moved. Correnti seconded to approve the course with the following correction:

Laboratory hours per week: 0
Total class meeting hours per semester or session: 7 1/2 - 15

Motion carried unanimously.

MUS 209: Survey of Non-Western Music (2 semester cr.) Bakke moved. Sibley seconded to approve. Motion carried unanimously.

MUS 335: Organization of Instrumental Music Program (2 semester cr.)
Mathiason moved. Sibley seconded to approve.
Motion carried unanimously.

MUS 375: Band Conducting (2 semester cr.) Correnti moved. Bakke seconded to approve. Motion carried unanimously.

MUS 377: Choral Conducting (2 semester cr.) Correnti moved. Bakke seconded to approve. Motion carried unanimously.

MUS 376: Orchestral Conducting (2 semester cr.) Wasson moved. Bakke seconded to approve. Motion carried unanimously.

MUS 290: Music Topics (1-3 semester cr.)
This course was removed from the package at the department's request.

MUS 370: Composition--Level 3 (1-3 semester cr.) Bakke moved. Correnti seconded to approve. Motion carried unanimously.
