# APAC Minutes February 7, 1995

Elizabeth Danielson clarified the Criminal Justice waiver which was questioned at the 1/31/95 meeting. The committee had agreed to waive the graduation requirement that 8 of the last 12 credits be taken at MSU for all Criminal Justice majors who undertake law enforcement training.

#### 1. Liberal Studies Recommendations

Moore moved. Pemble seconded to approve the Liberal Studies course designation recommendations. Motion carried unanimously.

# 2. Semester Conversion: Honors Program

# Major Changes - New Courses:

Honors 200: Honors Colloquium (4 semester cr.) Wasson moved. Correnti seconded to approve. Motion carried with one opposed.

Honors 300: American Society (4 semester cr.)
The Liberal Studies Committee approved this course for Division C designation.
Wasson moved. Sibley seconded to approve.

Motion carried with one opposed.

Honors 301: Masterpieces of Literature (4 semester cr.) The Liberal Studies Committee approved this course for Division D1 designation.

Boe moved. Correnti seconded to approve.

Motion carried with one opposed.

Honors 305: Good and Evil (4 semester cr.)
The Liberal Studies Committee approved this course for Division D designation.
Boe moved. Wasson seconded to approve.

Motion carried with one opposed.

#### Minor Changes:

Boe moved. Correnti seconded to approve the minor changes as listed under Section II of the Analysis form. Motion carried unanimously.

# Major Changes - Other:

There are no other major changes.

Approval of the Honors Program's Semester Conversion Package: Pemble moved. Boe seconded to approve the Honors Program semester conversion package. Motion carried with one opposed.

# 3. Semester Conversion: International Programs

Approval of the International Programs' Semester Conversion Package:

Moore moved. Correnti seconded to approve the International Programs' semester conversion package with the following revisions made by Dieter Berninger, Humanities/MCS Department Chair:

# 4. Semester Conversion: Core Courses (LBST)

Approval of the CORE Courses (LBST) Semester Conversion Package: Pemble moved. Wasson seconded to approve the courses and the semester conversion package:

201A & 201B: Beautiful & Good 5 semester cr. 202A & 202B: Civilizations & Migrations 5 semester cr.
```

VP Badal requested that the credits be increased from 5 to 6 semester credits. Students must take both courses (A & B) to earn credits. Sheila Coghill, Coordinator of the CORE Program, concurred with this request.

Roy moved to amend the motion to reflect the following credit change:

Motion to amend carried unanimously.

Motion to approve the CORE Courses (LBST) semester conversion package carried unanimously.

#### 5. Semester Conversion: Latin Courses

Approval of Latin's Semester Conversion Package: Pemble moved. Sibley seconded to approve Latin's semester conversion package and the following courses: The Liberal Studies Committee approved Latin 101 & 102 for Division E.

Latin 101: Beginning Latin I (4 semester cr. Latin 102: Beginning Latin II (4 semester cr.

Latin 201: Intermediate Latin I (4 semester cr. Latin 202: Intermediate Latin II (4 semester cr.

Jill Frederick, Coordinator of the Latin program, stated that Latin 201 and 202 courses are usually taught as tutorials.

Motion carried unanimously.

#### 6. Semester Conversion: Medical Records

Approval of the Medical Records' Semester Conversion Package. Bakke moved. Correnti seconded to approve the Medical Records semester conversion package.

Molly Moore, advisor and liaison of this degree which is offered between MSU and NW Technical College-Moorhead, fielded questions. The degree consists of courses from within several divisions. This conversion will affect only those students who started under the quarter system this year and will finish next year under the semester system. Students entering this program next Fall will receive the AAS in Medical Records Technology from Northwest Technical College-Moorhead.

Motion carried unanimously.

#### 7. Semester Conversion Women's Studies Program

Major Changes and Approval of the Women's Studies Program Semester Conversion Package:

Correnti moved. Boe seconded to approve the changes to the minor listed under Section III of the Analysis form and the Women's Studies semester conversion package.

The Women's Studies minor consists of cross-listed courses from other departments.

Motion carried unanimously.

# 8. Semester Conversion Department of Sociology, Anthropology & Criminal Justice

(Package tabled at the 1/24/95 APAC meeting)

Mathiason moved. Boe seconded to remove the semester conversion package from the table.

The package was tabled at the 1/24/95 APAC meeting because of the committee's concern with the variable credit option the department is proposing in their conversion package. They felt this subject should be discussed and debated on an individual basis outside of an APAC meeting before action could be taken on the package.

The 1 credit writing or recitation courses are separate from the 3 credit courses they apply to. The 1 credit courses must be acted on separately from the 3 credit courses and are options in some of the Sociology and Anthropology courses, not Criminal Justice. Dr. Joel Charon, Chair of the Sociology/Anthropology and Criminal Justice department, stated his concerns and supporting arguments for the 1 credit writing or recitation option. Dean Strong also supports this package. Dr. Charon submitted a document to the committee listing the number of sections offered in past years and the students served in those classes. After lengthy discussion, the Committee decided to discuss the package as presented.

# Major Changes - New Courses:

SOC 211: Social Theory (3 semester cr.) Boe moved. Sibley seconded to approve.

The committee felt they should act on the 1 credit writing or recitation option before discussing each individual course.

Boe moved to table SOC 211: Social Theory until the 1 credit writing or recitation option is acted on. Bakke seconded. Motion to table carried unanimously.

Bakke moved to approve the principal of the 1 credit writing and recitation option the department is proposing in their package. Pemble seconded to approve.

Motion to approve the principal of the 1 credit writing and recitation option the department is proposing in their package failed with eight opposed and six approvals.

Mathiason moved to approve the principal of the 1 credit <u>writing</u> option. Bense seconded to approve.

Motion to approve the 1 credit <u>writing</u> option failed with eight opposed and six approvals.

Dr. Charon stated his concern with the decision of not approving the 1 credit writing or recitation courses. He felt that the committee's decision was not based on student needs and mentioned that only one member discussed concerns with him prior to this meeting. He felt that his department may have to reconsider their entire semester conversion package because of the committee's rejection of the w/r option. Elizabeth Danielson reminded the committee members and the members of the Sociology, Anthropology and Criminal Justice department, that APAC is an advisory committee to the President. Dr. Charon agreed to let the members act on the remainder of the semester conversion package excluding the w/r option courses.

Bakke moved. Moore seconded to remove SOC 211: Social Theory from the table for approval. Motion carried unanimously.

SOC 215: Population (3 semester cr.)
Moore moved. Correnti seconded to approve
Motion carried unanimously.

SOC 307: The Courts and Legal Professions (3 semester cr. Roy moved. Mathiason seconded to approve. Motion carried unanimously.

SOC 308: Introduction to Gerontology (3 semester cr.)
Moore moved. Wasson seconded to approve.
The Social Work department submitted a memo stating their support of this course. This course is cross-listed with Social Work 308.
Motion carried unanimously.

SOC 309: Law and Society (4 semester cr.)
Moore moved. Correnti seconded to approve.
This course is cross-listed with CJ 309: Law and Society.
Motion carried unanimously.

SOC 310: Dominant-Subordinate Group Relations (3 semester cr.) Mathiason moved. Moore seconded to approve. Motion carried unanimously.

SOC 320: Sociology of the Family (3 semester cr.) Pemble moved. Correnti seconded to approve. Motion carried unanimously.

SOC 322: Urban Sociology (3 semester cr.)
Zarrett moved. Mathiason seconded to approve.
Motion carried unanimously.

SOC 323: Community (3 semester cr.)
Zarrett moved. Correnti seconded to approve.
This course is cross-listed with ANTH 323: Community.
Motion carried unanimously.

SOC 330: Sociology of Religion (3 semester cr.) Pemble moved. Zarrett seconded to approve. Motion carried unanimously.

SOC 333: Sociology of Gender (3 semester cr.) Zarrett moved. Mathiason seconded to approve. Motion carried unanimously.

SOC 355: Society and the Ecosystem (3 semester cr.) Mathiason moved. Zarrett seconded to approve. Motion carried unanimously.

SOC 404: Social Power (3 semester cr.) Olday moved. Moore seconded to approve. Motion carried unanimously.

SOC 410: Gerontology: Policy and Practice 4 semester Pemble moved. Sibley seconded to approve. Motion carried unanimously.

SOC 450: Issues in Sociology (4 semester cr.) Boe moved. Correnti seconded to approve. Motion carried unanimously.

SOC 414: Seminar: Symbolic Interactionism (4 semester Boe moved. Correnti seconded to approve.

Pemble moved to reduce the credits to 3 semester cr. Roy seconded. Charon concurred with the credit reduction. Amended motion carried unanimously.

SOC 416/516: Violence in the Family (3 semester cr.) The Graduate Council approved this course. Boe moved. Correnti seconded to approve. Motion carried unanimously.

SOC 420: Trends in American Society (3 semester cr.) Mathiason moved. Zarrett seconded to approve. Motion carried unanimously.

CJ 200: Introduction to Criminal Justice (4 semester cr.) Pemble moved. Correnti seconded to approve. Motion carried unanimously.
