**APAC Minutes**  
May 9, 1995

**1. Transfer of "D" Courses - Informational Item**

This was placed on the agenda as an informational item only. Current SUS policy does not allow students to transfer in courses in which a grade of D was earned. It is possible, because of eligibility provisions in the Higher Education Act, that Board policy will change. If that happens, MSU policy will change simultaneously.

Karen Knighton was present to explain that this is a federal requirement based on agreements we have with other schools. One of the requirements for eligibility for Federal Financial Aid states that we would have to accept D grades on the same terms as consortium agreements. VP Midgarden is in the process of defining how this will affect transferring under the merged system and agreements we have with other schools, e.g. Concordia and NDSU. If MSU accepts D grades here, we would then have to accept D grades from institutions we have agreements with.

**2. Liberal Studies Recommendations**

The APAC committee accepted the Liberal Studies Committee recommendations made at their 4/27/95 meeting to approve Art 100: Elements of Art for Division D.
