Effective Fall 1996, Elementary & Early Childhood majors will be required to complete one of these science courses as part of their B1 Liberal Studies requirements:

Biology 105: Exploring Biology (3 cr.)
Physics 120: Fundamental Physical Science (3 cr.)
Physics 121: Fundamental Physical Science II (3 cr.)

Pemble stated that other courses in Biology, Chemistry and Earth Science could serve as B1 courses as well.

Pemble amended the motion requesting the Elementary & Early Childhood department discuss the possibility of adding courses with those three departments. Mathiason seconded.
Amended motion carried unanimously.

Motion to approve the change in requirements carried unanimously

4. New Center

Academic Progress Credit Change

Moore moved. Sibley seconded to approve

The New Center for Multidisciplinary Studies requests that the number of A-F graded credits taken by New Center students before they are switched to Academic Affairs for the oversight of their academic progress be changed, from 8 credits to 12 credits.

Rae Offutt, Richard Bolton and Del Corrick were present to answer questions regarding this proposal. For years the transition point for students was 24 quarter credits, but because overcrowding was a concern several years ago, it was changed to 12 quarter credits. Semester conversion changed it to 8 semester credits.

Motion carried unanimously.
