APAC Minutes
January 19, 1999

Members present: Reed (chair 4:00-4:15), Midgarden (chair 4:15-5:00), Conteh, Dunkirk, Enz-Finken, Jeppson, Klenk, Klindworth, Mowry, Ruth, Sanderson, Schmidt, Scholl, Shimabukuro, Smedman.

1. Department of Mass Communications

Change course title of MC 375: Case Studies in Public Relations (3 cr.) to: Case Studies in Organizational Public Relations.

(This item was tabled at the 11/17/98 APAC meeting.)

Smedman moved. Conteh seconded to remove changing the course title of MC 375: Case Studies in Public Relationships, from the table and amend the motion to approve changing the course title to: Case Studies in Organizational Public Relations.

Amended motion carried unanimously.

2. Department of Mathematics

Minor Change:

Change course level and title of MATH 263: Calculus III (4 cr.) to MATH 323: Multi-Variable and Vector Calculus

(Materials submitted with the 12/15/98 APAC agenda.)

Change course level of MATH 129: Fundamentals of Applied Mathematics (3 cr.) to MATH 229.

Change course level of MATH 134: Introduction to Probability and Statistics (4 cr.) to MATH 234.

Change course level of MATH 136: Applied Statistics (4 cr.) to MATH 236.

Change course level of MATH 138: Statistical Methods (2 cr.) to MATH 238.

Change course level of MATH 203: Foundations of Number Systems (3 cr.) to MATH 303.

Change course level of MATH 204: Informal Geometry (3 cr.) to MATH 304.

The committee had no objections to the minor changes. Mattson explained that some of the courses were 200-level courses under the quarter system but were converted to 100-level semester courses. Some freshmen students prematurely enroll in these courses due to the 100-level number and have an unsatisfactory finish in the course (42% are either D, F or W). Smedman was concerned whether the math courses would continue to transfer from Fergus Falls Community Colleges to MSU at the same course level. Mattson said that faculty in the department with math education expertise evaluate transfer courses and will continue to do so.

3. Department of CSIS

Major changes:

Smedman moved. Conteh seconded.

Sanderson stated if they maintain the current major, which has a wide variety of electives and demands additional faculty preparation, then faculty are not as able to achieve scholarly activity. Packaging the major differently allows more time for scholarly activity. This major satisfies the curriculum requirements for accreditation. The curriculum has been called "traditional" and he explained that one reason it is traditional, is because 40% of accounting graduates are transfer students and so come to MSU from a variety of institutions at different stages of completion of the accounting major.

7. Department of Speech/Language/Hearing Sciences

New Emphasis:

Pre-audiology Emphasis (Hearing Only)

Midgarden stated that an emphasis is a program in which at least fifty-one percent of the courses are shared with an existing, approved program. Tieglund said this is really a marketing strategy and that they expect approximately four students a year to go through this program. This emphasis is not frequently offered at other institutions. This will assist students who are seeking a professional degree in audiology. Coppens stated this emphasis is not offered by any of the other MnSCU institutions. He could not recall specific names of non-MnSCU institutions that offer a similar emphasis. APAC will act on this emphasis at 2/2/99 meeting.
