April 15, 2003 APAC Minutes

Members present: Midgarden, chairperson; Bolduc, Borchers, Conteh, Dobitz, Enz Finken, Flack, Gess, Jeppson, Mills, Olerud, Quigley, Schwartz, Shaw, Shreve, Simpson, Stockrahm, Wallert, and Weckler.

Members absent: Max, Ruth & Strong.

1. Approval of the 4/1/03 APAC Minutes

Conteh moved. Borchers seconded to approve the 4/1/03 APAC Minutes. Motion carried unanimously.

2. Proposal to reduce the number of credits currently required to earn a Bachelor of Arts Degree. (President Barden was present to answer questions and listen to the discussion.)

This proposal was discussed at the 3/4/03 APAC meeting. The Student Senate voted unanimously w/one abstention in favor of reducing the number of credits required to earn a bachelor of arts degree to 120 credits. The results of the student survey were 507 in favor and 123 not in favor (71 of the not in favor votes were students in senior year status). The feedback from College Advisory Boards were e-mailed to APAC members as they were received by the Office of Academic Affairs.

The committee discussed the following:

- This change would reduce the number of required elective credits (not liberal studies or required credits.)
- If the quality of education would decline and this would lower the standards of MSUM.
- Students could continue to take courses even though they had fulfilled the number of credits required for their B.A. degree.
- The reduction of laboratory time with the approval of the academic calendars is as important as this proposal.
- Other institutions in the nation have set their requirement at 120 credits.
- Accurate advising is always important.
- ❖ 120 credits is requested because that will equal 15 credits per semester for 4 years and satisfies Minnesota financial aid.

Wallert moved to reduce the number of credits required to earn a Bachelor of Arts degree from 128 credits to 120 credits to be implemented fall semester 2003. Conteh seconded. Motion carried with 11 in favor and 2 opposed.

3. MnSCU Change in Board Policy of setting a 40-credit minimum in the number of upperdivision credits. [The previous minimum was 1/3 of the total number of credits, which meant that programs with more than 121 credits had to have more than 40 upper-division credits.]

Shreve moved. Gess seconded to approve changing the current policy of 1/3 of the total number of credits (43 credits) to a 40-credit minimum in the number of upper-division credits required in any MSUM major.

Motion carried unanimously.

4. Languages & Cultures

These courses were tabled at the 2/18/03 and 3/4/03 APAC meetings. Jim Weckler was in attendance to answer questions about the revised new courses.

Weckler moved. Schwartz seconded to remove the following new courses from the table:

CHIN 250: Beginning Chinese Calligraphy (2 cr.)

CHIN 350: Chinese Calligraphy (2 cr.)

Motion to remove the courses from the table for approval carried unanimously.

Motion to approve carried unanimously.

5. Business Administration Department

Jim Swenson was present to answer questions.

Enz Finken moved. Borchers seconded to approve decreasing the number of hours a Department of Business Administration major must work to receive one internship credit and reduce the requirement from 45 to 40 hours of work per credit.

Motion carried unanimously.

6. Mathematics Department

Ari Wijetunga was present to answer questions.

Bolduc moved. Schwartz seconded to approve increasing credits of MATH 421: Actuarial Science I from 1 to 3 cr. Also change course description and prerequisites. Motion carried unanimously.

7. Multidisciplinary Studies

Jarilyn Gess and Dennis Jacobs were present to answer questions.

Flack moved. Bolduc seconded the following new courses:

MDS 210: Understanding Crisis (2)

MDS 212: Issues in Abuse (1)

Motion carried unanimously.

8. Counseling and Personal Growth Center

Thomas Lane and Sandi Schuette were present to answer questions.

Conteh moved. Shreve seconded to approve the new course:

Kindergarten licensure may be added to an elementary education (grades 1-6) license by successfully completing EECE 433: Preschool/kindergarten curriculum and the accompanying practicum (EECE 467K). This is available only to students seeking licensure prior to September 1, 2005.

Motion carried unanimously.
